Subject: Invitation to bid for the rights to host the 2028 (and/or 2030) Lifesaving World

Championships

Leuven, 23 January 2022

Dear,

The Lifesaving World Championship (LWC) is the most important competitive event on the calendar of the International Life Saving Federation (ILS). The LWC must satisfy many requirements, most significantly the needs of the ILS members and the goals of the organisation.

The ILS Board of Directors is seeking bids to host the 2028 (and/or 2030) Lifesaving World Championships (abbreviated "LWC 2028"). The ILS is determined to ensure a professional and transparent system in selecting future hosts of the World Championships. The process is as follows:

Bidding/Hosting Organisation

The Bidding/Hosting Organisation shall be:

- A National Lifesaving Federation that is a Full Member Federation/Organisation of ILS, or
- A Host City/Group/Agency/Organisation, preferably in co-operation with an ILS Full Member.

	 An official letter from the bidding organisation confirming its candidacy. The Bid Form and Budget Form and all requested annexes duly completed and signed by two authorised signing officers of the bidding organisation. The payment of a non-refundable 8,000 Euro bid evaluation fee before the deadline of 15 June 2023. This fee will cover the cost for accommodation, meals and local transportation of the Bid Evaluation Committee and will support the administration cost of the site visit and the bid evaluation process. 	Bid Evaluation Committee travel (in economy class).
	A bid will be considered invalid if one or more of the above listed requirements requests are not fulfilled before the set deadline. Relevant attachments that support the Bid can be mailed later.
From 15 June to	The ILS Event Management Committee:
15 July 2023	 Scrutinises the bid documents that were received to check their validity. If some clarifications are needed, the Bidders will be informed.
	Composes the Bid Evaluation Committee that will consist of a
	minimum of three people who can be present at all bid evaluations.
	Defines, with the Bidders, the Bid inspection dates.
From 15 July to 15 September 2023	The Bid Evaluation Committee will do the bid inspection, which will include:
	 Site visits of the competition, alternative and training pools, the competition and alternative beach, the briefing and meeting sites, the accommodation venues for delegates, technical officials, team officials and competitors, etc.
	 Formal bid presentation: the Bidding Organisation must make a formal bid presentation during the site visit.
	 During the bid inspection, written feedback will be given directly to the bidder on areas of strength and weakness, and areas where deficiencies are present and where improvements are expected to be made (i.e. unsuitable pool, insufficient meeting space, etc.). Written confirmation of potential remedial actions is required prior to
	the departure of the Bid Evaluation Committee. After the Bid Evaluation Committee has left the venue no further communication with the Bidder will be made. Each inspection visit will take at least 2 days, not including the arrival
From 15 August to	and departure days.
From 15 August to 15 September 2023	The Bid Evaluation Committee will evaluate the bids and issue a report to the ILS Event Management Committee.
September 2023	The ILS Event Management Committee will evaluate the Report of the Bid Evaluation Committee and issue recommendations to the ILS Board of Directors.
October 2023	The Board will receive the Report of the ILS Event Management
	Committee and its recommendations. The Board of Directors will, by

secret ballot, vote on the recommendations. After the Board of Directors' decision an announcement of the successful Bid will be done.

The successful Bidder will be formally informed in writing and so will the unsuccessful Bidders, with feedback from the Event Management Committee.

Notes:

- No presentations by the Bidding Organisations will take place to the Sports Commission or the Board of Directors prior to the selection vote on the candidatures.
- Feedback will be provided to those who are unsuccessful by the ILS Event Management Committee Chair.

The proposed timing for the proposed LWC should avoid the coincident with other major or important ILS events and other world-wide events.
