ILS AWARDS AND RECOGNITION POLICY

1. INTRODUCTION

People are the ILS's most valuable resource. As such it is essential that the ILS acknowledge the range of contributions that are made by Individual Members and/or Member Federations/Organisations that by their actions have contributed to the furtherance of lifesaving and the goals of the ILS.

Such contribution may be achieved through lifesaving rescues, technical and administrative efforts, financial support, etc. The primary focus is to recognise the voluntary contribution that an individual has made be it through a long history of involvement or alternatively for a specific task or project that has been undertaken.

2. CHANCELLERY

The ILS has set up a Chancellery which is delegated by the Board of Directors with the responsibility and authority to review and accept proposals for honours and awards for individuals, teams and organisations and submit those for approval or ratification to the Board of Directors.

The Council of Meritorious Order of the ILS (the Chancellery) is composed of six members:

- The Grand Master is the ILS President.
- The Chancellor and Secretary is the ILS Secretary General.
- The remaining four Chancellery Members are the four ILS Vice-Presidents.

The awarded people's names and countries are published on the ILS web site.

3. ORDER OF LIFESAVING

3.1. Introduction

The Order of Lifesaving is a group of special awards conferred by the ILS upon deserving persons. The ILS Order of Lifesaving comprises three (3) grades:

1. Knight
2. Grand Knight
3. Commander

3.2. Attribution Procedure

1. The initial request is made confidentially by one of the authorities defined in the point below and addressed to the ILS Secretary General. Such nomination shall contain a summary of the reasons for the nominee's suitability for the award.
2. The ILS Secretary General reviews the application for completeness and transmits it to the Chancellery. If the nomination is not coming from an ILS Member Federation/Organisation, the ILS Secretary General will solicit the opinion of the Member Federation/Organisation.

3. The Chancellery meets in camera. If the Chancellery declines to issue an award, no further action is taken and the person submitting the nomination is advised. If the Chancellery recommends approval of the award, it is then brought before the Board of Directors.
4. The Board of Directors approves or disapproves the recommendation of the Chancellery.
5. Appropriate notifications and awards are given.

3.3. Ceremony

The Medal, the Certificate and the Citation Diploma of the Order of Lifesaving are presented to the recipient by the ILS President, Grand Master of the Order, or by his/her designated representative.

At the presentation ceremony, the following proclamation is made:

"Mr/Mrs/Miss (name), in the name of the International Life Saving Federation in recognition of your devotion to the cause of lifesaving, and to the ideals of the ILS, I make you (award) in the Order of Lifesaving".

3.4. Nominations

The persons who can nominate a candidate:

- The Members of the ILS Board of Directors.
- The Presidents of an ILS Member Federation/Organisation in good standing.

3.5. Attribution

The attribution is done on the occasion of:

- The organisation of an official event.
- The organisation of a championship.
- Other exceptional circumstances, but not more than two (2) years after the acceptance of the award by the Chancellery.

3.6. Eligibility rules

Commander

Minimum qualifications: Any person who, in a voluntary capacity, has given extraordinary service to the ILS, the WLS¹ or the FIS² over a period of at least twenty (20) years as an Officer, a Member of the Board of Directors, or a Member of a Commission/Committee.

Such a person must, at a minimum, have served as a Member of an ILS Member Federation/Organisation for no less than thirty (30) years.

Grand Knight

Minimum qualifications: Any person who, in a voluntary capacity, has given extraordinary service to the ILS, the WLS³ or the FIS⁴ over a period of at least fifteen (15) years as an Officer, a Member of the Board of Directors, or a Member of a Commission/ Committee.

Such a person must, at a minimum, have served as a Member of an ILS Member Federation/Organisation for no less than twenty-five (25) years.



Knight

Minimum qualifications: Any person who, in a voluntary capacity, has given extraordinary service to the ILS, the WLS or the FIS over a period of at least ten (10) years as an Officer, a Member of the Board of Directors, or a Member of a Commission/ Committee. Such a person must, at a minimum, have served as a Member of an ILS Member Federation/ Organisation for no less than twenty (20) years.



3.7. Administration

Practical points:

- The names of the awarded people are published on the ILS web site.
- The call for nominations to all ILS Member Federations/Organisation is done 6 months before a major ILS event.
- The awarding is preferably restrictive to four people per ceremony.

4. ILS PATRON

Selection Process

Nominated by the ILS Chancellery and decided by majority vote of the ILS Board of Directors and the General Assembly in consultation with the appropriate Member Federation/Organisation.

Minimum Qualifications

Any person who has contributed to the furtherance of lifesaving and the goals of the ILS in a manner of enduring, importance.

Major Benefits

- Duration of Membership: Life.
- Personalised Membership Card.
- Membership Certificate.
- Award of Patron of the ILS.
- Name listed in the ILS Golden Book and the ILS web site.
- Name properly advertised in the ILS documents.

Description

The Patron will receive a nominative invitation for the ILS Lifesaving World Championships, the ILS Conference and other ILS events and receive a special and appropriate treatment at these series, e.g. a special seat, invitation to present medals, public introduction and thanks at awards. The Patron will receive a Patron's Award/Decoration at a special ceremony organised for this purpose. The Award comprises a decoration, a mini-decoration, a rosette, an appropriate case and a specially framed certificate.

5. ILS HONORARY LIFE GOVERNOR

Selection Process

Nominated by the ILS Chancellery and decided by majority vote of the ILS Board of Directors and the General Assembly in consultation with the appropriate Member Federation/Organisation.

Minimum Qualifications

Any person whose has contributed to the furtherance of lifesaving and the goals of the ILS in a manner of enduring and significant importance. The ILS will have no more than four Life Governors at a given time, preferably one per ILS Region.

Major Benefits

- Duration of Membership: Life.
- Personalised Membership Card.
- Membership Certificate.
- Award of Life Governor of the ILS.
- Name listed in the ILS Golden Book and the ILS web site.
- Name properly advertised in the ILS documents.

Description

The Life Governor will receive a nominative invitation for the ILS Lifesaving World Championships, the ILS Conference and other ILS events and receive a special and appropriate treatment at these events, e.g. a special seat, invitation to present medals, public introduction and thanks at awards. The Life Governor will receive a Life Governor's Award/Decoration at a special ceremony organised for this purpose. The Life Governor will be invited at Board of Directors Meetings, General Assemblies and other events organised by the ILS or under the aegis of the ILS. At these events, the Life Governor will have the right to attend and participate, however shall have no voting rights at such meetings. The Life Governor can represent the ILS when requested to do so by the ILS President. The Life Governor can undertake any agreed task assigned by the ILS Board of Directors.

6. PRESIDENTS'S AWARD

Selection Process

Granted in the discretion of the ILS President

Minimum Qualifications

Any person whose actions have significantly contributed to the International Life Saving Federation or globally to its aims and objectives as defined in the ILS Constitution. No more than three President's Awards shall be issued each year.

7. CITATION OF MERIT

Selection Process

Granted by the ILS upon request of the National Federations/Organisations. The Citations are approved by the ILS President and ratified by the Board of Directors.

Minimum Qualifications

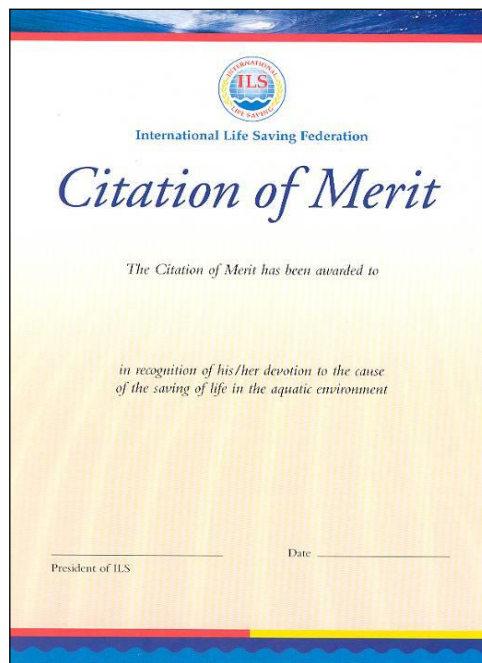
Any person whose efforts and contributions has achieved a positive impact on the furtherance of lifesaving and the goals of the ILS. These efforts can be achieved through the individual effort in the development or implementation of lifesaving initiatives within the Member Federation/Organisation or the ILS.

Major Benefits

- Citation of Merit Certificate.
- ILS Medal.
- Name listed on the ILS Web Site.

Description

The person will receive a Citation of Merit Certificate in a presentation cover and an ILS Medal.



8. ILS MEDAL



9. MEDAL OF RESCUE

9.1. Introduction

The Rules of Distinction for the Medal of Rescue a group of special awards conferred by the ILS upon deserving persons. The Medal of Rescue Comprises two (2) categories:

1. International Lifesaving Rescue Medal of Valour
2. International Lifesaving Rescue Medal

9.2. International Lifesaving Rescue Medal of Valour

Selection Process

Nominated by the President of any ILS Full Member Federation/Organisation in good standing for an act in the same country and decided by majority vote of the ILS Board of Directors.

Minimum Qualifications

Any lifesaver or group of lifesavers who is a member of any ILS Member Federation/Organisation in good standing who has knowingly and selflessly intervened in an instance of the most extreme peril in the aquatic environment in an effort to save the life of another person. No more than one Medal of Valour shall be issued each year, unless by unanimous decision of the Board of Directors. To be eligible, the lifesaver or group of lifesavers must first receive the highest award for valour, if any, by the lifesaver's National Federation/Organisation and the action must be documented and verified. The application should be received within three years after the rescue.

9.3. International Lifesaving Rescue Medal

Selection Process

Nominated by the President of any ILS Full Member Federation/Organisation in good standing for an act in the same country and decided by majority vote of the ILS Board of Directors.

Minimum Qualifications

Any person without formal lifesaving training, who has knowingly and selflessly intervened in an instance of extreme peril in the aquatic environment in an effort to save the life of another person. No more than one ILS Medal shall be issued each year, unless by unanimous decision of the Board of Directors. The action must be documented and verified. The application should be received within three years after the rescue.

10. RECOGNITION OF RETIRING VOLUNTEERS

Volunteers who have served in an elected or appointed office and made a substantive contribution to the ILS shall be recognised upon their retirement with a token of appreciation commensurate with their tenure and contribution. A formal presentation by the ILS President and/or ILS Secretary General or their delegate shall be made at the ILS Dinner, Elective General Assembly or other significant ILS event where the individual who is being recognised is in attendance. If it is anticipated that the individual shall not attend such an event within one (1) year of retirement, a suitable opportunity for presentation shall be arranged in their country of residence.

Recognition of a retiring ILS President and/or ILS Secretary General shall be co-ordinated by the Chancellery. Directors and Members shall be provided with a structured mechanism to present gifts as is suitable to the occasion but shall not have the opportunity to speak unless an invitation to do so has been provided for in the official programme as determined by the Chancellery.

On the retirement of a regional Vice-President, one individual appointed by the Region shall also be invited to speak and/or make a presentation.

Words of appreciation and gifts between individuals should be conveyed on an individual basis, outside the formal presentations to retiring volunteers.

11. RECOGNITION OF HOST ORGANISING COMMITTEES

The ILS shall formally recognise the contribution of key members of Host Organising Committees, the senior government official at each level of government and the senior official from other partner organisations as appropriate to the circumstance. Mementoes will be presented by the ILS President and/or ILS Secretary General or their delegate. A structured opportunity for members to present gifts of appreciate shall be provided. Words of appreciation from individual members should be conveyed on an individual basis outside the formal presentation.

12. INTERNATIONAL LIFESAVING TECHNICAL OFFICIALS AWARDS

Selection Process

The ILS Technical Official Service Award is conferred to Technical Officials who have officially applied, were officially endorsed by their national federation, have effectively officiated at a number of Lifesaving World Championships (LWC) for at least two days per Championship. Attendance does not have to be at consecutive LWC.

Minimum Qualifications

- Bronze Award: Any person who has officiated at 3 Lifesaving World Championships.
- Silver Award: Any person who has officiated at 5 Lifesaving World Championships.
- Gold Award: Any person who has officiated at 8 Lifesaving World Championships.
- Platinum Award: Any person who has officiated at 10 Lifesaving World Championships.
- Diamond Award: Any person who has officiated at 12 Lifesaving World Championships.
- Knight in the order of Lifesaving: Any person who has officiated at 14 Lifesaving World Championships and 5 Lifesaving World Championships at a senior level (either a Sectional Referee, Deputy Sectional Referee, Area Referee, Event Director, Deputy Chief Referee, Chief Referee) and is nominated by the Sport Commission to the ILS Chancellery.



13. INTERNATIONAL LIFESAVING HALL OF FAME

13.1. Background

The Hall of Fame is to be registered at and located in the ILS Headquarters. An area is set up in the Headquarters that is dedicated to preserving lifesaving's special place in history and to honour international lifesaving's rich and proud heritage.

The ILS Hall of Fame will permanently display, commemorate and recognise members and teams who have achieved outstanding accomplishments and exceptional contributions to the development of International Lifesaving. These achievements are not restricted in relation to the area of their contribution but must have been inspirational in application to international lifesaving activities.

The ILS Hall of Fame may be displayed at other locations such as the International Swimming Hall of Fame and ILS Full Member Federations/Organisations but only with the prior formal approval of the ILS Board and subject to a formal agreement with the ILS.

The inaugural inductions into the ILS Hall of Fame was conducted at the ILS Centennial Celebration in 2010. Subsequent inductions will occur at World Championships and/or General Assemblies and/or ILS Conferences. Individuals and Members of Teams will each be presented with an ILS medal appropriately endorsed with their award.

13.2. Nomination procedure and administration

Nominations for the Hall of Fame may only be made by a Full Member Federation/Organisation in good standing, the ILS President, a Member of the ILS Board of Directors or an ILS Commission Chair.

The nominations are to be submitted on an appropriate form. All nominations are to be forwarded to the ILS from the nominator with the endorsement of the Member Federation/Organisation. Nominations not endorsed by the Full Member Federation/Organisation from the country of the nominated person will not be considered.

Nominations must be accompanied by a photo of sufficient quality for scanning and a conclusive history covering the service and outstanding or pioneering achievements and exceptional contributions to ILS which address the criteria. The accompanying history is restricted to two pages for each nomination.

13.3. Assessment, Approval and Notification Procedure

Assessment will be made by the ILS Chancellery. The ILS Secretary General will receive and submit the nominations together with the recommendations from the nominator to the Chancellery for subsequent recommendation to the ILS Board. The Chancellery will make recommendation to the ILS Board of Directors for each nomination received in the appropriate category of the award and on the appropriate form. Any member of the Chancellery being considered for this award is to be eliminated from the assessment process.

Assessment by the Chancellery will be made against the criteria detailed below. The decision of the ILS Board will be final.

Nominations not recommended by the Chancellery will not be submitted to the ILS Board and will be treated as confidential. Unsuccessful nominations may be re-submitted for consideration after a period of two (2) years or at the time nominations are due prior to the succeeding General Assembly, whichever is the sooner.

Some nominations may be recommended but held over for reconsideration for induction at a later date. This will be advised to the nominator and Member Federation/ Organisation.

All successful nominees will be advised in writing of their induction by the Secretary General on behalf of the ILS President. The ILS Secretary General will also advise the recipient of the award and induction arrangements into the Hall of Fame.

All nominations are to be treated as confidential and unsuccessful nominations will be advised only to the nominator/s for the award.

13.4. Application Conditions

Initial nominations to include notable persons who have contributed to International Lifesaving through WLS and FIS prior to the formation of the ILS and with the formation of the ILS in 1994.

Other nominations will cover the period since the inception of the ILS in 1994.

All endorsed nominations for the initial induction must be forwarded to ILS by no later than 15 September 2009. Nominations must be listed by category. Closing dates for nominations after 2009 will be advised by the ILS Secretary General.

13.5. Number of nominees

Nominations for the ILS Hall of Fame will only be considered every two years and there will be a general limit of eight (8) nominees inducted into the Hall of Fame every two (2) years. The International Life Saving Federation recognises the prestigious nature of this award and will consider applications appropriately. In special circumstances the ILS Board may approve the induction of more than eight (8) nominees in any two-year cycle by unanimous approval of the Board on the recommendation of the Chancellery.

13.6. ILS awareness

Special efforts will be made in ILS newsletters, publications and the ILS web site to draw the attention of Member Federations/Organisations as a whole to the award.

13.7. Timing and presentation

Induction into the ILS Hall of Fame will take place bi-annually at World Championships and /or World Congress of Member Federations/Organisation, at a time and location to be determined by the ILS President.

13.8. Criteria and Hall of Fame categories

Those recommending persons or teams for this award shall do so in accordance with the award criteria detailed below. All nominations must be to a specific category and must be endorsed by the Member Federation/Organisation to which the individual or team is affiliated. Nominations not endorsed by the Full Member Federation/Organisation from the country of the nominated person will not be considered.

“International” contribution is that which is considered to be significant and additional to any contribution made to the Members or Teams own Member Federation/Organisation and has helped the objectives of the ILS.

The categories are:

- a. International Lifesaving.
- b. International Lifesaving – Sport.

International Lifesaving

The Hall of Fame recognises those individuals and teams who have been involved in all or any significant facets of International lifesaving operations. Examples are active patrolling, lifeguarding, education, training and examination, rescue services, medical, development, research and the general support activities involved in lifesaving search and rescue, emergency response and surveillance, presidents, administrators, managers, directors, commission chairs and members, convenors, committee chairs and members, secretaries and treasurers, etc. This category also recognises those involved with the development of lifesaving services and water safety at an international level. It is intended that individuals or teams must have contributed beyond their ILS competitive achievements to be considered for this award.

International Lifesaving Sport

The Hall of Fame recognises those individuals and teams who have been involved in all or any significant facets of International lifesaving sports. Examples are active participation, refereeing and/or any general support activities involved in lifesaving sport. Eligible persons are presidents, administrators, managers, directors, commission chairs and members, convenors, committee chairs and members, secretaries and treasurers, athletes, team managers, team officials, (members, trainers, coaches, etc.), technical officials, etc. This category also recognises those involved with the development of lifesaving sport at an international level. It is intended that individuals or teams must have contributed beyond their ILS competitive achievements to be considered for this award.

13.9. Criteria

The following criteria are to be addressed in each nomination:

- 13.9.1. Nominations may only be for one category, however, evidence supporting the nomination covering activities relevant to the other categories should be provided

and will be taken into consideration. It is important that the complete career of the nominee is put forward to permit a total assessment.

- 13.9.2. Nominees are to be in good standing with the ILS and the respective Member Federation/Organisation. Controversy should be avoided. For example, persons charged with using performance-enhancing drugs, having been disciplined for contravention of the code of ethics of the ILS or their Member Federation/Organisation, or who have been found guilty of criminal offences (whether connected with the ILS or not) should not be nominated. Nominees under investigation will not be considered until all or any charges against them are cleared.
- 13.9.3. Nominations should draw names from a broad range of members or teams who have been, or are currently;
- Past and present ILS office holders and administrators.
 - Past and present office holders of Member Federations/Organisations.
 - Active/patrolling members.
 - Rescue Services members / groups.
 - Lifesaving support groups.
 - Examiners/Trainers.
 - Competitors.
 - Competition Officials.
 - Coaches.
 - Advisors (e.g. medical, research, etc.).
 - Outstanding individuals who have contributed significantly to the ILS.
- 13.9.4. Nominations must clearly demonstrate that individuals or teams have:
- Displayed exceptional and sustained service to international lifesaving in the specific category.
 - Achieved outstanding individual or team accomplishments which set the individual or team apart from other lifesavers, teams or administrators at an international level.
 - Displayed sustained excellence over a long period of time at an international level to the category for which they are nominated.

Any enquiries about the ILS Hall of Fame should be directed to the ILS Secretary General.

14. ILS RULES FOR DONOR AWARDS

Selection Process

For all Awards given hereunder the person must be nominated by the ILS Chancellery and decided by a majority vote of the ILS Board of Directors.

Minimum Qualifications

A generous offer to provide advice and assistance to the ILS, including assisting with future fundraising efforts, and a contribution to the ILS of € 25,000. (This may include earlier contributions).
